## FEEDING RECOMMENDATIONS

This is a supplement and not a feed. Sufficient grazing and or roughage must be available at all times.

Keep lick troughs filled and prevent gluttonous eating by hungry animals. A constant daily intake can help prevent poisoning.

Before feeding a NPN containing lick, feed and ordinary salt/phosphate lick for at least 7 days.

Feed to cattle and sheep on low quality veld/roughage.

Cattle: 500 g per animal per day

Sheep: 100 g per animal per day
